This Addendum includes questions and answers received by 3:00 P.M. on November 21, 2013 and a **revised Proposal Form**.

Clarifications, Questions and Answers

1. Is the total budget 80k for both equipment and PIP together? Or, are they 80k each?

We have decided to increase the budget for play improvements to \$110,000. The budget is now \$110,000 for both PIP and equipment. Please use the **revised Proposal Form**, which is now posted on the Town website.

2. Within the surfacing specification page 8 states that the PIP area is 6,000 yet the drawing is closer to 4,000. Which is the correct amount of PIP?

4,000 square feet

3. Is the art in the sketch, in the bid package, the final design?

Yes.

4. Does the city have a color preference for the PIP (color affects price)?

We prefer the closest possible match to the colors shown in the PDF without creating custom colors.

5. Will the contractor be providing the curbing around the playground?

Yes. The general contractor is responsible for installing concrete curbing.

6. What is the sub base material required and whose scope is it under?

The general contractor is responsible for the sub-base, which is 4" of compacted stone. In addition, the general contractor is also responsible for all drainage.

7. The requirement for the swing is ambiguous. Do you want it included? Can you state the level of importance for things like the ramp, swings, and roofs to the design?

Swings are highly desired. Ramps are important if they can truly provide access to the upper level in a meaningful manner. Roofs are optional.

8. How can we obtain CAD files?
