LUMO Revisions Update	Mr. Witsil asked staff to confirm that the Board has not missed an opportunity to participate in the LUMO update process.  The LUMO Update is temporarily on hold. Mr. Gibson reported that the Council gave the Town Manager direction to focus Town staff's efforts on completing the Ephesus Church-Fordham plan. Work on the LUMO is anticipated to resume later in the year.  Ms. McClintock asked how the LUMO Update affects the Ephesus Church-Fordham process. Mr. Gibson responded that they are two separate processes. Legislative update	Mr. Gibson briefly reviewed the legislative update provided to the Stormwater Board via email on February 6, 2014.  Ms. McClintock asked if the provision in House Bill 74 that requires a unanimous vote to approve environmental regulations is applicable to the Ephesus Church-Fordham plan. Mr. Gibson replied that it would not be applicable as the Ephesus-Fordham is a rezoning and not an environmental regulation.	N/A	N/A
Focus Areas	a. Ephesus Church/Fordham – Mr. Witsil stated that the Stormwater Advisory Board needs to figure out its role in the process. The Board wants to be sure that local, state, and federal requirements are met and flooding doesn't worsen.  Mr. Gibson provided a project overview. The current path is to rezone the project area to a form-based code. On a parallel path, transportation and stormwater concepts are being developed. The current stormwater requirements are lot-by-lot; a district-wide plan is being proposed to include multiple structures that will provide water quality and not make flooding worse.  Each new construction project will pay an initial fee that will be used for future district stormwater BMPs. The taxing district revenues will pay for the operations and maintenance of the district structures. The Town proposes to spend \$10M on public improvements - \$8.8M for road improvements and \$1.2M for stormwater management structures. Mr. Retschle asked what the stormwater design criteria will be. Mr. Taylor responded that the staff is proposing to use the stormwater design criteria in the existing rules. New (increased) impervious areas would require treatment.  There is a Public Information Meeting on Thursday, February 20, 2014 at the Library. A brief presentation will be made at 4:30 pm and repeated at 5:30 pm. The draft stormwater design criteria are tentatively scheduled for presentation to the Town Council at its meeting on February 24, 2014.  A Council work session will be held on March 3, 2014.   - What are the target criteria?

- Has in-structure parking been considered?
   Consider allowing additional height to provide parking levels in/under the building. (I)
- To be helpful to the Council, what should the Board's role be and when is it needed? (I)
- The Board should make recommendations to the Council on the stormwater aspects. (I)
- It would be helpful to have a detailed list of projects that are being proposed for the \$10M. (I)
- Is there a guarantee that there are sufficient funds to build the necessary infrastructure and BMPs? (I)

Mr. Witsil invited Ms. Berndt, the Greenways Commission Chair, to share her board's perspective about the Ephesus-Fordham plan.

Ms. Berndt reported that the Greenways Commission is trying to follow and understand the Ephesus-Fordham proposal. The Greenways Master Plan includes several long-term recommendations for consideration when the area is redeveloped. These include:

- Daylighting Booker Creek through the Eastgate Shopping Center.
- Providing underpasses at E Franklin St and Fordham Blvd to allow pedestrians and bicyclists to safely cross.

It would be helpful if the Ephesus-Fordham plan incorporated the Greenways Master Plan recommendations.
