Hi Mary Jane – I'm sorry that I will not be at tonight's Council Meeting as I'm attending the North Carolina Public Transportation Association's Annual Meeting. The following is a brief summary of the information that has been provided to Council on Transit related to the proposed Obey Creek project:

- As noted in the staff memo to Council on May 18, 2015 HNTB conducted a Traffic Impact Analysis for the project, which included projections on transit ridership (a very small % of the trips projected to be generated by the project):
 http://www.townofchapelhill.org/home/showdocument?id=27775.
 - o The cost estimate, in today's dollars, represents the cost to increase service on existing routes in the area to meet the projected ridership demands of the service at full build out. The estimate includes the cost of leasing buses (estimated at ~\$60,000 a year per bus) and the cost to operate the service. This estimate does not assume late night or weekend service, as these services do not currently operate in this are or many other areas of Chapel Hill.
 - o The developer has also proposed a contribution of an additional \$0.02 per square foot of completed heated building area to help fund transit service, which is projected at build out to generate around \$30,000 (the equivalent of half the cost of an annual bus lease). This is included in the current draft of the proposed Development Agreement.
 - o The Financial Analysis developed by the Town indicates that projected revenues exceed the cost of extending services to the proposed development, indicating that future Councils could consider allocating additional revenues to expand and/or improve Transit in this area.
- The cost of new transit services is usually covered for at least the first year by the jurisdiction implementing the service.
 - o As a partnership between the Town of Chapel Hill, Town of Carrboro and the University, a request for new service and/or an expansion of services is typically discussed by the Transit Partners Committee, which provides a recommendation to the jurisdiction(s) from which the request was generated.
 - o If approved, the jurisdiction(s) in which the service originates is responsible for paying the full cost of the new service for at least one year. If the service

meets performance standards, the Partners Committee then discusses sharing the cost of the new service through the current Transit funding formula.

- The current draft of the proposed Development Agreement requires the developer to design and construct transit infrastructure consistent with Town standards.
- Rapid transit service is envisioned in the project area and the North South Corridor Study (http://nscstudy.org/) has been initiated in the Martin Luther King Jr.
 Boulevard South Columbia US 15-501 South Corridor (between the Eubanks Park and Ride and Southern Village Park and Ride). While local and regional plans envision rapid transit within this important transportation corridor this study represents the first phase of the federal process for funding.
 - o The current draft of the proposed Development Agreement requires the developer to build transit facilities to accommodate a future rapid transit project.
