


Process to Consider Possible Future Use of Historic Town Hall

As you know, many citizens of Chapel Hill were disappointed when our Town decided it could no longer afford a museum and were unwilling to support it with any funds. (As a former Chair of the Board, I was particularly disappointed.) We now are pursuing a unique opportunity to open a new museum and relocated Visitor's Center in the old town hall once vacated by the IFC Kitchen. This is a brief summary of the activities that have taken place with regard to the utilization of the old town hall as a relocated

- We have reviewed the report provided by the County for the upgrade of the old town hall. While a number of us believe that the estimates are on the high side for the repairs that need to be made we recognize that a variety of different sources of funds will be necessary to not only renovate the building but up-fit the space for both the visitor center and the museum.

- Analyze Economic and Social Costs and Benefits
