



Supporting entrepreneurs requires tackling both low-hanging fruit and systemic issues

Resources for new entrepreneurs are overwhelming and difficult to locate

Young professionals must leave to find affordable housing, parking, transit, & family activities

There is no personal or career growth trajectory for young professionals in Chapel Hill

UNC could do more to support Chapel Hill entrepreneurial ecosystem

Launch, UNC, and Chapel Hill must work together to support our community's entrepreneurs

Relationships with businesspeople help towns retain graduates

"Sticky" incentives like mortgages, children in school, and spouses with jobs keep entrepreneurs in place








Political leadership, strong vision, and a willingness to weather criticism are required to create long-term changes Tech companies are unlikely to create high number of jobs





Launch Accelerator can be tweaked to better support new entrepreneurial ventures









Successful accelerators provide intense education and structured mentoring to participants







Concentrated Consultation

72-200 short meetings with mentors and customers over early days of accelerator help founders focus on themes and revisit their implicit assumptions

Transparent Disclosure

Observing pitches, displaying goals and progress publicly, and working in close proximity to cohort-members prod founders to keep up intense effort

Standardized Activities

Mandatory, sequenced mentor meetings and educational seminars force founders to consider broad, collectively exhaustive strategy decisions

73% invested in educational and other services, with only three offering robust independent programming

- Educational programming is commonly offered, but social activities are not
- Mentoring takes the form of meetings with coaches or entrepreneurs in residence
- Financial resources deployed to offer seed funding or grants and to hire additional staff











Most accelerators provide funding, but split in terms of cultivating wide or narrow industry network






Successful organizations typically to focus on one core competency (investing, accelerator, or coworking)






New activities from Launch, Chapel Hill, and UNC can help retain businesses and fill storefronts

Recommendation: Launch Chapel Hill should organize a municipal hackathon



- Hackathons are competitions conducted over 24-48 hours where individuals or teams present creative solutions to predefined problems
- Connect students, local entrepreneurs, and municipal leaders over meaningful community issues
- Straightforward planning and relatively inexpensive

Recommendation: Open Office Hours, beginning with EIRs & SBTDC and expanding over time








- Entrepreneurs in Residence and Small Business and Technology Development Center
- Office hours allow entrepreneurs to access needed guidance for new and existing ventures
- Can help orient founders as to the appropriate resources available for their stage, scale, and industry

Recommendation: Entrepreneurial Advisory Committee to keep "voice of customer" central





- Approximately 7 small business owners and entrepreneurs meeting monthly
- Focused on improving diversity of voices and ideas surrounding entrepreneurship support in Chapel Hill
- Increased connections can create a mentoring pipeline



Long-Term: Kenan-Flagler should target scholarships to retain entrepreneurs in Chapel Hill



- Current scholarship policy does little to promote long-term reinvestment in Chapel Hill
- Leading business schools offer entrepreneurship scholarships, but none tied to local business community
- One or two MBA scholarships could attract entrepreneurs with a desire to build a business in Chapel Hill
- Structure to disincentivize students from relocating after graduation

Long-Term: Town of Chapel Hill should explore multi-use alternatives to fill storefronts



- Baltimore City revitalized a struggling neighborhood by creating dedicated Arts District
- Repurposed vacant buildings as low-cost living and working studios to retain talent from leaving for larger cities nearby
- Similar opportunity to reimagine space use in Chapel Hill to promote entrepreneurship

EY ReVive - Themes

- Economic diversification driven by increase in entrepreneurial small businesses
- Chapel Hill needs to do a better job connecting the resources and human capital of UNC with the broader community
- Downtown needs investments in retail revitalization and in livability improvements (public transportation, greenspaces, bike lanes)
- Major roadblocks to change include housing and office space affordability, traffic/parking, permitting, and a mass exodus of college-educated talent

- Founder of Wave NC; Working with Town of Chapel Hill on economic development proposals
- Launch Accelerator was a great way for Willie to build his confidence as an entrepreneur
- There are so many resources available it can be overwhelming to figure out where to start
- Young professionals do not see a growth trajectory for themselves in Chapel Hill
- Lack of unified leadership makes it impossible to fix the underlying problems causing people to leave

Patrick Mateer



- Founder and CEO of Seal the Season
- Mentorship and skills building were most impactful parts of Launch Accelerator, especially working with the Entrepreneurs in Residence
- Town of Chapel Hill and University of North Carolina are seen somewhat synonymously, and both struggle with racial and social justice issues
- Chapel Hill does not have enough to offer entrepreneurs or young professionals 25-55 in terms of social life or affordability



Mike Wesner



- Principal and Chief Imagination Officer of Enrollment Fuel
- Joined Launch Accelerator due to "entrepreneurial loneliness," but did not find community or innovative spirit he hoped to find
- Skilled talent does not want to relocate, and it is too expensive to attract people to Chapel Hill
- Parking is a barrier to activities and businesses on Franklin Street
- Lack of unified entrepreneurial leadership in Triangle



Kristin Hiemstra



- Founder and President of The Art of Potential
- Lack of centralized resources for young entrepreneurs – even people who are looking cannot find it
- Chapel Hill is not currently a fit for young professionals (unlike Charlotte, Asheville, or DC)
- Parking, transit, and housing are one part of the problem, but so are nightlife and family-friendly, community activities




Sheryl Waddell



- Director of Innovate Carolina Global Network
- Town of Chapel Hill needs to focus on creating true incentives around taxes and leases
- UNC could do more to provide space, interns, and training to local businesses
- Launch needs clarity around its core mission in order to identify stakeholders and then target what needs Launch can meet



Steli Efti & Hiten Shah



- Y Combinator Alumni
 - Co-Founder and CEO of Close
 - Founder of Crazy Egg and KISSmetrics
- Participating in Y Combinator gave them more credibility as entrepreneurs than they would have had otherwise
- Less well known accelerators have to really prove their value proposition in order to attract talented founders




- Current Associate Dean for Student Integrated Learning at Maryland Institute College of Art (MICA) in Baltimore, MD

 - Maryland & Baltimore established tax incentives
- MICA finds it much easier to retain graduate students in Baltimore than undergraduate students

- Mayor of Tallahassee (2014-2018)
- Making a town hospitable for entrepreneurs requires bold political leadership with a vision that is strong enough to withstand criticism because changes take time to pay off
- Smaller municipalities need to have a response to the demand for urbanization among college graduates, such as livability, walkability, and other "city" amenities

Chris Bingham's research shows trends among successful accelerators

- Accelerators can improve continued existence, follow-on funding, web traffic, and employee growth of their ventures
- Positive impacts are not universal, and level of acceleration is not completely dependent on having a developed ecosystem
- Complement rather than substitute for founder pre-entry experience

- Learning is the key mechanism, not sorting or signaling
- Successful accelerators provide an environment in which entrepreneurs learn how to do things and which things to do
- Although the ventures do pivot, they can avoid costly mistakes by creating "conversational prototypes" with their mentors

Ventures and founders learn in environments focused on "BIP Consultation" from outsiders

- Broad many interactions with variety of knowledge sources, should be interactive and cumulative
- Intensive full time endeavor focused on learning, slowing down trial-and-error experimentation and product design allows smarter subsequent experimentation
- Paced founders need structured learning with defined points for decision-making and action to allow advice to build in the best direction instead of constantly reinventing the business
- Consultation focused on the current venture, not generalized best practices; comes from domain experts, customer interviews, cohort peers, accelerator director, and seminar speakers





Entrepreneurship-Focused MBA Scholarships

- UC Berkeley Haas School of Business
 - Brian Maxwell Fellowship \$80,000 awarded to individual who has "demonstrated entrepreneurial spirit and a drive to create and implement innovative projects, products, and ideas"
 - Mike and Carol Meyer Fellowship \$20,000 awarded to students with undergraduate degrees in engineering or science and intend to pursue an entrepreneurial career
- MIT Legatum Center for Development & Entrepreneurship: Legatum Center Fellowship – tuition, travel, prototyping support, mentors, and educational seminars provided to 20-25 students dedicated to building and scaling ventures in the developing world
