Police Station Property Update

The Town Council is continuing to consider the long-term land use and remediation options for the Police Station property, located at 828 Martin Luther King Jr Blvd. The latest option includes the Town entering into the North Carolina Department of Environmental Quality's Brownfields Program and partnering with Belmont Sayre, a local developer, to create a mixed-use redevelopment of the property that could include a new Municipal Services Center, retail, and housing.

Hi Ann,

On behalf of our project team, I'm writing to share some updates about the remediation work at the Police Station property:

- We are continuing to work with the contractor on the final steps for the first phase of the remediation project.
 Remaining steps include: reseeding, replacing the super silt fence along the trail, and trench repair along the embankment. Again, the need for trench repair stems from stormwater runoff on the upland portion of the site, which has been remedied by the recently installed stormwater device (berm and swale).
- We are currently reviewing the second draft of the **Human Health and Ecological Risk Assessment** report. We are also awaiting an updated version of the **interim remedial measures** report. We will post/share the final versions with you when they become available.
- As we noted earlier, at the Town Council's December 2nd meeting they asked staff to issue a request for qualifications (RFQ) to compare costs for siting a new Municipal Services Center at the Police Station property (versus another location) and for generally exploring what can be done on the Police Station site. On March 5th, the Council met again to receive an update on the remediation process and to discuss the results of the RFQ process. Council met again today in a work session format to discuss the redevelopment concept of the selected RFQ proposal team. The Council is continuing to explore its options and no decisions have been made. As always, we will continue to keep you posted on this and any other updates.
