Town Council Meeting – The Parks and Recreation Department Staff tentatively plans to provide an overview of the facilities, programs, services, and needs of the Department at the Town Council's June 1, 2022, work session. A proclamation declaring July as National Parks and Recreation Month will be introduced. As part of this presentation, Commission members will be invited to share information about activities and projects they support.

Community Programs - "April is for Earth" In March and throughout the month of April the Town invites residents to celebrate Earth Day all month long. Residents are invited to get outside, appreciate natural spaces, and learn about local sustainability efforts. Look for the Tree Icon and Green Titles on page 8 of our RECREATE Guide or see our April is for Earth Programs Online here.

Spring & Summer Program Registration: Parks & Recreation has released its spring program brochure and summer camp guide, which can be viewed here. Featured programs include Earth Day and spring themed program options at all locations. The Eggstream Egg Hunt and Campfire and Movie in the Park return this season.

Summer day camp registration for Chapel Hill and Orange County residents began on Tues., April 5. This year, Parks & Recreation intends to offer camps at 80% capacity and offer an additional location at a school in order to accommodate anticipated demand.

Parks, Open Space Reserve Areas, Greenways, and Bikeways Map – The interactive map has been updated to include further refinement to define and identify Open Space. The map is scheduled to be released in April for Earth Day. The Commission provided input on the map at meetings earlier this year.

<u>Greenways, Sidepaths, and Parks Projects Progress</u>: Following are brief updates. Commission members should feel free to contact the staff if they have any questions or comments.

Cedar Falls and Hargraves Parks Tennis Court Projects: Parks staff and design team representatives from WithersRavenel met with the Technical Review Team (TRT) on March 29 to share the 60% Cedar Falls tennis court reconstruction plans and receive TRT members' input on what is needed for permitting. Another meeting will be scheduled with this team to review the Hargraves Park tennis court resurfacing project.

Staff received the geotechnical report for Hargraves Park Tennis Courts. The engineer's first option recommended the complete replacement of the courts using the same subsurface construction method for addressing the poor soil conditions being pursued at Cedar Falls Park. The second option is to construct over the existing courts, which is what is programmed and funded for this project. The 60% percent set of plans is due in early May.

Ephesus Park Drainage Project: A contractor has completed a drainage project around the perimeter of the courts. The project was recommended by a geotechnical study as a possible way to reduce issues on the courts. The project included the expansion of a concrete walkway, an extension of the gravel walkway, a channel drain, two catch basins, underground pipes and a drainage swell around two sides of the tennis and pickleball courts. See photos of the work below. The next step in remediation will be resurfacing of the tennis courts; this work is expected in the summer.





Metropolitan Planning Organization (MPO) Announces Funding of Fordham Sidepath and Morgan Creek Trail Projects: The Parks & Recreation and Planning Departments are excited to share that the Durham-Chapel Hill-Carrboro Metropolitan Planning Organization (MPO) will be providing a total of \$1.43 million in funding to support the Morgan Creek Greenway – West section extension and the Fordham Boulevard Sidepath project. The \$1.27 million awarded to the Morgan Creek Greenway project will supplement \$1.1 million in existing 2015 Town greenway bond money in order to finish the design documents and construct the West Section, which extends from the existing trailhead at NC 54 bypass to Smith Level Rd. in Carrboro.



The \$160,000 award for Fordham Boulevard Sidepath will supplement the funding already received from the Town and the Federal Highway Administration. A news release announcing this award can be found here.

Community Splash Pad Project: Members of the work group reviewed feasibility study qualifications submitted by six firms. A proposal has been requested from CJT PA & 80 West Team to complete the study
