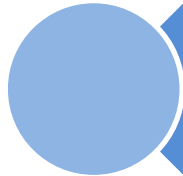

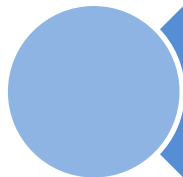

15 Year Capital Program

- Pay-go Funded (Annual Budget)
- Debt & Grant Funded (multi-year project budgets)
- Financing Plan
- Debt Fund





CDBG Grant

Initial Public Forum for CDBG held November 10, 2021

- Committee currently reviewing applications
- FY 2022 award = \$418,300

Next Steps:

- *April 6 - Second Public Forum*
- *May 4- Recommended CDBG & Home Plans*



HOME Program

Orange County HOME Consortium deadline for completing applications was Feb 25, 2022

- ***Next Steps:***

- *April 2022 – HOME Program Review Committee recommendations*
- *Annual Action Plan submitted to HUD May 17, 2022*



Public Housing Capital Grant Funds Program

Amount of Public Housing Capital Grant Funds for FY23 is unknown at this time

- *A preliminary program based on the expected reduced funding level is presented in memo*
- *A final recommended plan will be presented in April*

Public Transportation Grants

- **Estimated funding levels:**

- *Federal \$2 million*
- *State \$3 million*
- *Other Federal planning funds*

- *Transit Budget will be presented to the Public Transit Committee by April 2022*

Downtown Service District

- *6.4 cent tax – improvements to Downtown*
- *Estimated funding for FY23 \$397,000*





Potential Legislative Proposals

- **Legislative requests for 2022 legislative session**
 - General Assembly will convene in the coming months for the short session
 - Proposals can be considered at an upcoming Council meeting
 - Town Council is expected to meet with the Legislative Delegation in April
