Hi Ann,

On behalf of our project team, I'm writing to share another update.

We met with the Council on May 15 and June 12 to discuss possible interim remedial measures for the property. The Town proposed interim remedial measures as a way to begin addressing the coal ash contamination near Bolin Creek and the greenway while additional decisions are being made about the future location of the Police Station.

As part of the Town's FY20 budget, the Council has appropriated funds for taking the interim remedial measures outlined in this <u>report</u> (also bulleted below). These steps were supported by the <u>preliminary risk analysis</u> performed by the Town's risk assessor, Duncklee & Dunham. The Council also asked that staff perform routine inspections of silt fencing and additional sampling of the creek area every six months and after major storm events. The plan is to implement the interim remedial measures beginning this summer as part of the completion of the trail construction project. As you know, this project was previously reviewed by the state but delayed due to hurricane Florence.

Interim Remedial Measures and Next Steps:

- Place additional signage to keep trail users on the path
- Implement interim remedial measures to remove contamination closest to Bolin Creek and the existing/proposed trail segment that runs along the Police Station property
- Complete the Bolin Creek Trail MLK Jr. Blvd underpass and connector
- Conduct periodic inspections and sampling
- Perform post-construction sampling
- Generate report to update human health risk assessment and include ecological risk assessment
- Communicate regularly with the Council and the community about the activities listed above

Second, regarding the most recent update below, we anticipate a draft of the full risk assessment report to be issued in July. A final report will be issued in the fall. This report will also include the results of the interim remedial measures and the ecological screening.

Once the interim remedial measures are in place, we expect to resume the conversations with Council and the community regarding remediation options and possible future use scenarios for the Police Station property.

On behalf of our project team, I'm writing to share an update.

The Town has selected Duncklee & Dunham to perform the Human Health and Ecological Risk Assessment associated with the Police Station property. As a first step, this work will include a detailed analysis of the data and information gathered to date, as well as any additional sampling that is needed to complete human health and ecological risk calculations. These risk calculations will be used to help inform the Council of any risks associated with the condition of the property today (a baseline), as well as the level of any risks that could be associated with different remedial options. As a next step, the staff is planning to return to the Council in May with a preliminary update, as well as any decision points that relate to the current budget process. A final risk assessment report is slated for completion by no later than July 30, 2019.

Concurrent with the work above, the Town will apply for a determination of eligibility under the NC DEQ Brownfields program in the coming weeks. A draft application is being finalized now.

Also, following the risk assessment process outlined above, we anticipate moving into steps 2 and 3 (also described in the email below).

- 2. Hold up to four additional public meetings to continue: (a) sharing information about the condition of the site, (b) gathering and answering questions from the public and (c) getting additional feedback about a possible reuse scenario; and
- 3. Return to Council with updates, a determination of Brownfields eligibility from NC DEQ, and a broader range of remediation options.

We will send another update in the next 45-60 days.

On behalf of our project team, I'm writing to check in and share an update as we continue to evaluate the option of a Brownfields application for the Police Station site.

In our last email, we mentioned that our team is working on the items below that have been authorized by Council.

- 1. Apply for a determination of eligibility under the NC DEQ Brownfields program;
- 2. Hold up to four additional public meetings to continue: (a) sharing information about the condition of the site, (b) gathering and answering questions from the public and (c) getting additional feedback about a possible reuse scenario; and
- 3. Return to Council with updates, a determination of Brownfields eligibility from NC DEQ, and a broader range of remediation options.

Concurrent with step 1 and ahead of steps 2 and 3, the Town has issued an RFP for a Human Health and Ecological Risk Assessment. A team is reviewing those proposals now and expects to select a firm by the week of February 18th. From there, we plan to engage the selected firm in a risk assessment to help inform the Council's decision about the future use of the property. Once that work is complete, we plan to move ahead with steps 2 and 3 above.
